This type of association is open to public organizations, diplomatic missions and multilateral institutions. Members in this category do not have the right to cast any votes.

### 10D. **Associate non-resident - Annual Fee \$1,000**

Membership in this category is open to American companies or individuals who have an interest in doing business in Iraq. Members in this category have the right to cast one vote and their company name, if one exists, will not be listed in the AmCham Membership directory.

### 10E. **Associate Iraqi Member - Annual Fee \$1,000**

Membership in this category is open to Iraqi businesses or individuals who have an interest in doing business with US companies. Members in this category have the right to cast one vote and their company name, if one exists, will not be listed in the AmCham Iraq Membership directory.

### 10F. **Non-Government (NGO) Membership - Annual Fee \$500**

Membership in this category shall be open to American and Iraqi organizations and with their offices registered in Iraq as NGOs. Members in this category do not have voting rights.
